*Entries without fees* will not be accepted. Acknowledgment of entries by written confirmation letter will be made as soon as possible <u>after trial closes</u>. If a <u>legible</u> email address is provided, an email confirmation of entry will be made as soon as possible as entries are received and processed.

**Post Dated Checks and Returned checks** do not constitute a valid entry fee. The Trial Secretary will add a collection fee of \$25 to the amount of each returned check.

*Bitches in Season* will not be admitted to the Trial. Any exhibitor with an entered bitch in season on the trial date will be refunded the entry fee less \$10.00 (each day) upon written certification by a veterinarian given to the Trial Secretary before the start of judging.

*Judges will not wait for any dog holding up a class.* Owners or agents are responsible for the presence of their dogs in the judging ring when they are called to be judged. Dogs may arrive any time prior to their scheduled time of judging. Dogs not required for further judging may be excused.
